#### Effects of cancellation

We will make the reimbursement using the same means of payment as you used for the initial transaction. We may withhold reimbursement until we have received the goods or you have supplied evidence of having sent back the goods. Whichever is the earliest.

Except where the goods are faulty, you will be required to bear the direct cost of returning the goods. For items that cannot be returned by post, we will at your request use reasonable endeavours to arrange a courier to collect the goods; the estimated maximum cost of this would be £10 per item.
